- In view of the continuing Covid-19 pandemic, the Ministry of Corporate Affairs ("MCA") vide its circular Nos.14/2020, 17/2020, 20/2020, 02/2021 and 21/2021 dated 8th April, 2020, 13th April, 2020, 5th May, 2020, 13th January, 2021, 14th December 2021 respectively (collectively referred to as "MCA Circulars") issued by the Ministry of Corporate Affairs ("MCA") (collectively referred to as "MCA Circulars") and SEBI vide its Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020 and SEBI/HO/CFD/CMD2/CIR/P/2021/11 dated January 15, 2021 has permitted the holding of the Annual General Meeting ("AGM") through VC / OAVM, without the physical presence of the Members at a common venue. In compliance with the provisions of the Companies Act, 2013 ("Act"), SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") and MCA Circulars, the AGM of the Company being conducted through Video Conferencing (VC)/ Other Audio-Visual Means (OAVM) hereinafter called as "e-AGM".
- Ministry of Corporate Affairs ("MCA") has permitted by its "Circular 14/2020" of 08th April, 2020, "Circular 20/2020" of 05th May, 2020 & General Circular No. 10/2022 of December 28<sup>th</sup>, 2022 to General Meeting by VC. And Section 173 of the Companies Act 2013 read with section Rules 3 of the Companies (Meetings of Board and its Powers) Rules, 2014 and MCA Notification, dated 15th June, 2021 enables to hold General Meeting through VC or OAVM.
- The deemed venue for **30**<sup>th</sup> e-AGM shall be the registered office of the Company.
- Pursuant to the provisions of the Act, a member entitled to attend and vote at the AGM is entitled to appoint a proxy to attend and vote on his/her behalf and the proxy need not be a member of the Company. Since this e-AGM is being held pursuant to the MCA Circulars through VC/OAVM facility, physical attendance of members has been dispensed with. Accordingly, the facility for appointment of proxies by the members will not be available for the e-AGM and hence the Proxy Form and Attendance Slip are not annexed to this Notice.
- Corporate members intending to send their authorized representative(s) to attend the meeting (e-AGM) are requested to send to the company a duly certified board resolution authorizing their said representative(s) to attend and vote on their behalf at the meeting.
- The Statement pursuant to Section 102(1) of the Companies Act, 2013 with respect to the special business set out in the Notice is annexed hereto.
- The facility of joining the e-AGM through VC/OAVM will be opened 15 minutes before and will be open upto 15 minutes after the scheduled start time of the e-AGM, i.e. from 02.45 P.M. to 03.15 P.M. and will be available for 1,000 members on a first-come first-served basis. This rule would however not apply to participation of shareholders holding 2% or more shareholding, promoters, institutional investors, directors, key and senior managerial personnel, auditors etc.

# Instructions:

- 1. The attendance of the Members attending the AGM/EGM through VC/OAVM will be counted for the purpose of ascertaining the quorum under Section 103 of the Companies Act, 2013.
- 2. Pursuant to MCA Circular No. 14/2020 dated April 08, 2020, the facility to appoint proxy to attend and cast vote for the members is not available for this AGM/EGM. However, in pursuance of Section 112 and Section 113 of the Companies Act, 2013, representatives of the members such as the President of



- India or the Governor of a State or body corporate can attend the AGM/EGM through VC/OAVM and cast their votes through e-voting.
- 3. In line with the Ministry of Corporate Affairs (MCA) Circular No. 17/2020 dated April 13, 2020, the Notice calling the AGM/EGM has been uploaded on the website of the Company at <a href="https://www.visioncinemas.in">www.visioncinemas.in</a>. The Notice can also be accessed from the websites of the Stock Exchanges i.e. BSE Limited and National Stock Exchange of India Limited at www.bseindia.com and www.nseindia.com respectively. The AGM/EGM Notice is also disseminated on the website of CDSL (agency for providing the Remote e-Voting facility and e-voting system during the AGM/EGM) i.e.www.evotingindia.com.
- 4. The AGM/EGM has been convened through VC/OAVM in compliance with applicable provisions of the Companies Act, 2013 read with MCA Circular No. 14/2020 dated April 8, 2020 and MCA Circular No. 17/2020 dated April 13, 2020 and MCA Circular No. 20/2020 dated May 05, 2020.
- 5. In continuation of this Ministry's <u>General Circular No. 20/2020</u>, dated 05th May, 2020 and after due examination, it has been decided to allow companies whose AGMs were due to be held in the year 2020, or become due in the year 2021, to conduct their AGMs on or before 31.12.2021, in accordance with the requirements provided in paragraphs 3 and 4 of the General Circular No. 20/2020 as per MCA circular no. 02/2021 dated January,13,2021.

#### THE INTRUCTIONS OF SHAREHOLDERS FOR E-VOTING AND JOINING VIRTUAL MEETINGSARE AS UNDER:

- **Step 1** : Access through Depositories CDSL/NSDLe-Voting system in case of individual shareholders holding shares in Demat mode.
- **Step 2** : Access through CDSL e-Voting system in case of shareholders holding shares in physical mode and non-individual shareholders in Demat mode.
- (i) The voting period begins on <Date and Time> and ends on <Date and Time>. During this period shareholders' of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date (record date) of <Record Date> may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.
- (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- (iii) Pursuant to SEBI Circular No. **SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020,** under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.
- (iv) Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed



entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

(v) In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

**Step 1** : Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.

- (vi) In terms of SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.
- (vii) Pursuant to above said SEBI Circular, Login method for e-Voting and joining virtual meetings for Individual shareholders holding securities in Demat mode CDSL/NSDL is given below:

- (xv) After selecting the resolution, you have decided to vote on, click on "SUBMIT". A confirmation box will be displayed. If you wish to confirm your vote, click on "OK", else to change your vote, click on "CANCEL" and accordingly modify your vote.
- (xvi) Once you "CONFIRM" your vote on the resolution, you will not be allowed to modify your vote.
- (xvii) You can also take a print of the votes cast by clicking on "Click here to print" option on the Voting page.

- (xix) There is also an optional provision to upload BR/POA if any uploaded, which will be made available to scrutinizer for verification.

- 1. The procedure for attending meeting & e-Voting on the day of the AGM/ EGM is same as the instructions mentioned above for e-voting.
- 2. The link for VC/OAVM to attend meeting will be available where the EVSN of Company will be displayed after successful login as per the instructions mentioned above for e-voting.
- 3. Shareholders who have voted through Remote e-Voting will be eligible to attend the meeting. However, they will not be eligible to vote at the AGM/EGM.
- 4. Shareholders are encouraged to join the Meeting through Laptops / IPads for better experience.
- 5. Further shareholders will be required to allow Camera and use Internet with a good speed to avoid any disturbance during the meeting.
- 6. Please note that Participants Connecting from Mobile Devices or Tablets or through Laptop connecting via Mobile Hotspot may experience Audio/Video loss due to Fluctuation in their respective network. It is therefore recommended to use Stable Wi-Fi or LAN Connection to mitigate any kind of aforesaid glitches.
- 7. Shareholders who would like to express their views/ask questions during the meeting may register themselves as a speaker by sending their request in advance at least\_10\_\_ days prior to meeting (on or before 19.09.2023) mentioning their name, demat account number/folio number, email id, mobile number at (company email id: <a href="mailto:visiontechindia@yahoo.com">visiontechindia@yahoo.com</a>). If any Votes are cast by the shareholders through the e-voting available during the EGM/AGM and if the same shareholders have not participated in the meeting through VC/OAVM facility, then the votes cast by such shareholders may be considered invalid as the facility of e-voting during the meeting is

#### MANAGEMENT DISCUSSION AND ANALYSIS

#### MEDIA, ENTERTAINMENT AND FILMS INDUSTRY GLOBAL OUTLOOK

India continues to be one of the fastest growing economies in the world. After the temporary deceleration due to the impact of demonetization and implementation of Goods and Services Tax (GST), the recovery in economic growth is now largely complete. It is estimated that GDP grew at fastest in the world during relevant financial year; there were several positive developments in the economy, which will further accelerate this growth over the next few years. The long-delayed GST was finally implemented and it will go a long way in improving the business environment in the country. Government's focus on infrastructure development, banking reforms and affordable housing, amongst others, will support the growth in the medium term. Growth in some segments of the rural economy has been slower in the recent past. However, forecast of a normal monsoon bodes well for the agriculture sector and would drive the rural consumption.

The Indian media and entertainment (M&E) industry witnessed another year of all-round growth. The pace of growth marginally accelerated in relevant financial year, despite the lingering effect of demonetization and the impact of GST roll-out. According to the FICCI-EY Report (Report), M&E industry grew by 12.6% YoY. Despite the strong growth over the past several years, India's per capita entertainment consumption is much lower than not only the developed markets but also countries with similar income levels. This provides a significant head room for sustained growth driven by rising disposable incomes and increasing access to entertainment content. According to the Report, the Indian M&E industry is expected to grow at a CAGR of 11.3% to 2,032 billion over the next three years, driven by growth in all the segments.

During the year, television increased its reach and engagement with the audience, further enhancing its reputation as the default entertainment medium. Print media continued to grow, albeit at as lower pace, due to multiple head winds faced during the year. The movie industry surpassed all previous records riding on a strong performance at both the domestic and the international box office. Online video consumption continued its exponential growth due to the increased availability of affordable data and contenton digital platforms. Following the auction of Phase III licenses, FM radio expanded into newer cities. Live Events growth was led by premium properties, activations, and sports events.

Your Company has started working towards production of Advertisement motion Pictures. However it is in earlier stages, based on market Condition, management plans to expand this segment.

- The Government is taking efforts to boost "MAKE IN INDIA" initiative in the media and entertainment industry.

#### **BUSINESS REVIEW AND GROWTH PROSPECTS**

Your Company is one of the Oldest Exhibition and Movie Processing Laboratory Companies in southern India having a group presence (through other entities) of approximately 50 years. The Promoters have restructured the Board for two major reasons; to meet regulatory requirements and to mitigate the risk with respect to Business Management, Management Up gradation and to receive expert backing from veteran professionals in the Industry.

It has also been making efforts to revamp the complete compliance structure of the Company to make it stakeholder friendly and ease of access to the Information.

The Company has also upgraded its websites to include online ticket bookings for its Cinema Screens and ease to Customers for a simple and easy cinema experience.

The Company has also started identifying areas where it can set up multiplexes and F&B store. The Company also plans to develop a unique brand name for its F&B stores to make it attractive and easy recognition amongst its customers.

Your Company has started working towards production of Advertisement motion Pictures. However it is in earlier stages, based on market Condition management plans to expand this segment.

### **RISKS & CONCERNS**

As it is normal and prevalent for any business, the Company also is likely to face competition from existing companies. There can be risks inherent in meeting unforeseen situations, not common in the industry. The biggest concern nowadays is the switchover of customers/audience from physical to online segment. There is all of a sudden change in the taste and preferences of the people due to covid pandemic. This needs to be noted and make necessary efforts to have a stand in the industry.

Your Company is fully aware of these challenges and is geared to meet them. Your Company also recognizes the risks associated with business and takes adequate measures to address the associated risks and concerns.

Rising up to the new challenges will only be possible when we scale-up the brand chain and put in efforts toward providing more and more satisfaction to the customers.

**Risk**: The Growth of Company is highly dependent on Income levels and Government policies, which directly impact leisure and entertainment industry.



**Mitigation**: The Company expects no major and material change in Income levels and thus the Foot fall shall not decrease in coming years.

Risk: Highly dependent on good films

**Mitigation**: The Company expects line up of good movies on basis of Internal Industry sources and which shall stand attractive to all class of Audiences, which will ultimately add to revenues of the Company.

Risk: High Capex to set up High Quality Screens

**Mitigation**: The Company seeks to set up Screens through Asset Light Model, where a partnership with local HNIs and Ultra HNIs of areas will be planned resulting into low capex and high income for the Company.

**Risk**: Identification of suitable location for New Cinemas and Multiplexes.

**Mitigation**: The Company currently have planned to expand its operations in Gujarat, Maharashtra and Certain parts of Southern India. For precise location identification, Company have hired one of the Leading Management Consultancy firms, who shall conduct spot verification and thorough Due Diligence for measuring commercial viability of the locations.

The Company has a system-based approach to risk management, anchored to policies and procedures and internal financial controls aimed at ensuring early identification, evaluation and management of key financial risks (such as market risk, credit risk and liquidity risk) that may arise as a consequence of its business operations as well as its investing and financing activities.

The Company has a proper and adequate internal control system to ensure that all assets are safeguarded and protected against loss from unauthorized use or disposition and those transactions are authorised, recorded and reported correctly. Accordingly, the Company's risk management framework has the objective of ensuring that such risks are managed within acceptable and approved risk parameters in a disciplined and consistent manner and in compliance with applicable regulation. It also seeks to drive accountability in this regard.

# **Report on the Financial Statements**

We have audited the accompanying standalone financial statements of M/s. # **Opinion**

In our opinion and to the best of our information and according to the explanations given to us, except the matter given in the "Emphasis of Matter" section, theaforesaid standalone financial statements give the information required by the Act in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at 31st March, 2023, and its profit/loss, its cash flows and changes in equity for the year ended on that date.



# **Emphasis of Matter**

- The balances reported as Trade Payable are subject to confirmation of balances from the Vendors.
- The aggregate of advance to subsidiary as on 31st March, 2022 was Rs. 668.90 Lakhs which has increased to Rs. 672.94 Lakhs as on 31st March, 2023. However, in the opinion of the management, these are good and recoverability are not doubtful. We obtained explanation from the Management regarding their judgement on the recoverability of these funds and found these judgment to be appropriate.
- Of Rs.977.96 lakhs of aggregate Trade Receivable as on 31<sup>st</sup> March, 2023, Rs. 938.03 Lakhs receivable from M/s. SI Media LLP, which accumulated during earlier periods. However, the net receivable from SI Media has reduced from Rs. 953.04 Lakhs on 31.03.2022 to Rs. 938.03 Lakhs as on 31<sup>st</sup> March, 2023. Also, the management is confident of its recoverability and we find the explanation provided by the management on the same appropriate.

Auditor's opinion is not modified in respect of the matter emphasized.

# Report On Other Legal And Regulatory Requirements

Notes forming part of Financial Statements

#### 1. CORPORATE INFORMATION

Vision Cinemas Limited is a public limited company incorporated in India and the Company has its primary listing on Bombay Stock Exchange.

The Company is engaged in the business of movie exhibition and commenced production of Advertisement Films during the year. The company primarily earned revenue from Advertisement Film Production.

#### 2. SIGNIFICANT ACCOUNTING POLICIES

#### **BASIS OF PREPARATION & PRESENTATION OF FINANCIAL STATEMENTS**

#### (a) Statement of Compliance

These standalone financial statements havebeen prepared in accordance with the Indian Accounting Standards (referred to as "Ind AS") as prescribed under section 133 of the Companies Act, 2013 read with Companies (Indian Accounting Standards) Rules as amended from time to time.

#### (b) Basis of measurement

The financial statements have been prepared on a historical cost convention and on anaccrual basis, except for certain financial instruments which are measured at fair value at end of each reporting period, as explained in the accounting policies below.

#### (c) Use of judgement, estimates and assumptions

The preparation of the financial statements requires the management to make judgements, estimates and assumptions considered in the reported amounts of assets and liabilities and disclosure relating to contingent liabilities as at the date of financial statement and thereported amounts of income and expenditure during the reported year. Estimates and underlying assumptions are reviewed on a periodic basis. Revisions to accounting estimates are recognized in the period in which the estimates are revised and in any future periods affected.

In particular, information about significant areas of estimation, uncertainty and critical judgments in applying accounting policies that have the most significant effect on the amounts recognized in the financial statements is included in the following notes:

#### i) Income taxes

The Company's major tax jurisdictions is India. Significant judgments are involved in determining the provision for income taxes, including amount expected to be paid/recovered for uncertain tax positions. In assessing the realizability of deferred income tax assets, management considers whether some portion or all of the deferred income tax assets will not be realized. The realization of deferred income tax assets is dependent upon the generation of future taxable income during the periods in which the temporary differences become deductible. Management considers the scheduled reversals of deferred income tax liabilities, projected future taxable income and tax planning strategies in making this assessment.

Based on the level of historical taxable income and projections for future taxable income over the periods in which the deferred income tax assets are deductible, management believes that the company will realize the benefits of those deductible differences. The amount of the deferred income tax assets considered realizable, however, could be reduced in the near term if estimates of future taxable income during the carry forward period are reduced.

#### ii) Impairment testing

Investments in subsidiaries, goodwill and intangible assets are tested for impairment annually and when events occur or changes in circumstances indicate that the recoverable amount of the asset or cash generating units to which these pertain is less than its carrying value. The recoverable amount of cash generating units is higher of value-in-use and fair value less cost to dispose. The calculation of value in use of a cash generating unit involves use of significant estimates and assumptions



which includes turnover and earnings multiples, growth rates and net margins used to calculate projected future cash flows, risk-adjusted discount rate, future economic and market conditions.

#### iii) Depreciation and amortisation

Depreciation and amortization is based on management estimates of the future useful lives of certain class of property, plant and equipment and intangible assets. Estimates may change due to technological developments, competition, changes in market conditions and other factors and may result in changes in the estimated useful life and in the depreciation and amortization charges.

#### iv) Other estimates

The preparation of financial statements involves estimates and assumptions that affect the reported amount of assets, liabilities, disclosure of contingent liabilities at the date of financial statements and the reported amount of revenues and expenses for the reporting period. Specifically, the Company estimates the probability of collection of accounts receivable by analyzing historical payment patterns, customer concentrations, customer credit worthiness and current economic trends. If the financial condition of a customer deteriorates, additional allowances may be required. The stock compensation expense is determined based on the Company's estimate of equity instruments that will eventually vest.

Fair valuation of derivative hedging instruments designated as cash flow hedges involves significant estimates relating to the occurrence of forecast transaction.

#### **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### (a) Functional and presentation currency

Items included in the financial statements of the Company are measured using the currency of the primary economic environment in which the Company operates (i.e. the "functional currency"). The financial statements are presented in Indian Rupee, the national currency of India, which is the functional currency of the Company.

#### (b) Investment In Subsidiary:

Investment in subsidiary company is carried at cost less accumulated impairment losses, if any. Where an indication of Impairment exists, the carrying amount of the investment is assessed and written down immediately to its recoverable amount. On disposal of investments in subsidiary companies, associate and joint venture companies, the difference between net disposal of proceedsand the carrying amounts are recognised in the statement of Profit and Loss.



#### (c) Property, plant and equipment

Property, plant and equipment are measured at historical cost or its deemed cost less accumulateddepreciation and impairment losses, if any. Historical Cost includes expenditures directly attributable to the acquisition of the asset.

When parts of an item of property, plant and equipment have different useful lives, they are accounted for as separate items (major components) of property, plant and equipment. Subsequentexpenditure relating to property, plant and equipment is capitalized only when it is probable thatfuture economic benefits associated with these will flow to the Company and the cost of the itemcan be measured reliably. Repairs and maintenance costs are recognized in the statement of profitand loss when incurred.

An item of property, plant and equipment is derecognized upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arisingon the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognized in the Statement of Profit and Loss.

The residual values, useful lives and methods of depreciation of PPE are reviewed at each financialyear end and adjusted prospectively, if appropriate.

Subsequent expenditure on additions and betterment of operational properties are capitalized, onlyif, it is probable that the future economic benefits associated with the expenditure will flow to the Company and expenditures for maintenance andrepairs are charged to statement of Profit & Loss as incurred.

#### (d) Depreciation/ Amortisation

Depreciable amount for assets is the cost of asset less its estimated residual value.

Depreciation has been provided on assets on the straight-line method, as per the useful life prescribed in Schedule II of the Companies Act, 2013.

The residual values, useful lives and methods of depreciation of property, plant and equipment arereviewed at each financial year end and adjusted prospectively, if appropriate. The Companyassesses at each Balance Sheet date whether there is objective evidence that a asset or a group of assets is impaired. An asset's carrying amount is written down immediately to its recoverableamount if the asset's carrying amount is greater than its estimated recoverable amount.

All the assets except building are at residual value as on 1st April, 2020 and hence depreciation is provided only on building value amount.

The residual values are not more than 5% of the original cost of assets.

#### (e) Leases

From April 1, 2019, Ind AS 116 'Leases' is applicable to all the listed companies. Ind AS 116 hascertain exemptions from the application of Ind AS – 116:

As per explanation and books of accounts provided to us, there are no lease payments done by the company and as per the explanation provided to us, no lease agreements are entered into by the company.

#### (f) Financial Instruments

All financial instruments are recognised initially at fair value. Transaction costs that are attributable to the acquisition of the financial asset (other than financial assets recorded at fair value throughprofit or loss) are included in the fair value of the financial assets. Purchase or sale of financial assets require delivery of assets within a time frame established by regulation or convention in themarket place (regular way trade) are recognised on trade date. While, loans and borrowings



andpayables are recognised net of directly attributable transaction costs.

For the purpose of subsequent measurement, financial instruments of the Company are classified inthe following categories: non-derivative financial assets comprising amortised cost, debtinstruments at fair value through other comprehensive income(FVTOCI), equity instruments at FVTOCI or fair value through profit and loss account (FVTPL), non derivative financial liabilities atamortised cost or FVTPL and derivative financial instruments (under the category of financial assetsor financial liabilities) at FVTPL.

The classification of financial instruments depends on the objective of the business model for whichit is held. Management determines the classification of its financial instruments at initialrecognition.

#### Non-derivative financial assets

#### i. Financial assets at amortised cost

A financial asset shall be measured at amortised cost if both of the following conditions are met:

- (a) the financial asset is held within a business model whose objective is tohold financial assets in order to collect contractual cash flows; and
- (b) the contractual terms of the financial asset give rise on specified datesto cash flows that are solely payments of principal and interest (SPPI) onthe principal amount outstanding.

They are presented as current assets, except for those maturing later than 12 months after thereporting date which are presented as non-current assets. Financial assets are measured initially atfair value plus transaction costs and subsequently carried at amortized cost using the effective interest rate method, less any impairment loss.

Financial assets at amortised cost are represented by trade receivables, security deposits, cash andcash equivalents, employee and other advances and eligible current and non-current assets.

Cash and cash equivalents comprise cash on hand and in banks and demand deposits with bankswhich can be withdrawn at any time without prior notice or penalty on the principal.

For the purposes of the cash flow statement, cash and cash equivalents include cash on hand, inbanks and demand deposits with banks, net of outstanding bank overdrafts that are repayable ondemand, book overdraft and are considered part of the Company's cash management system.

#### ii. Financial Assets at Fair Value through Other Comprehensive Income (FVTOCI)

For assets, if it is held within a business model whose objective is achieved by bothcollectingcontractual cash flows and selling financial assets and where the company has exercised the option classify the equity investment as at FVTOCI, all fair value changes on the investment are recognised in OCI. The accumulated gains or losses on such investments are not recycled to the Statement of Profit and Loss even on sale of such investment.

#### iii. Financial assets at Fair Value through Profit and loss (FVTPL)

Financial assets which is not classified in any of the above category is measured at FVTPL. These include surplus funds invested in mutual funds etc.

Financial assets included within the FVTPL category are measured at fair values with all changesrecorded in the statement of profit and loss.

#### Non-derivative financial liabilities Financial liabilities at amortised cost

Financial liabilities at amortised cost represented by borrowings, trade and other payables are initially recognized at fair value, and subsequently carried at amortized cost using the effective interest rate method. For trade and other payable maturing within one year from the Balance Sheetdate, the carrying value approximates fair value due to short maturity.



#### Financial liabilities at Fair Value through Profit and loss (FVTPL)

Financial liabilities at FVTPL represented by contingent consideration are measured at fair value withall changes recognized in the statement of profit and loss.

#### Derivative financial instruments and hedging activities

A derivative is a financial instrument which changes value in response to changes in an underlyingasset and is settled at a future date. Derivatives are initially recognised at fair value on the date aderivative contract is entered into and are subsequently re-measured at their fair value. The methodof recognizing the resulting gain or loss depends on whether the derivative is designated as ahedging instrument, and if so, the nature of the item being hedged.

The Company enters into derivative contracts to hedge the risks asserted with currency fluctuations relating to firm commitments and highly probable transactions. The Company does not usederivative instruments for speculative purposes.

The Company documents, at the inception of the transaction, the relationship between hedginginstruments and hedged items, as well as its risk management objectives and strategy forundertaking various hedging transactions. The Company also documents its assessment, both athedge inception and on an on-going basis, of whether the derivatives that are used in hedgingtransactions are effective in offsetting changes in cash flows of hedged items.

The effective portion of changes in the fair value of derivatives that are designated and qualify ascash flow hedges is recognised in Other Comprehensive Income. The ineffective portion of changesin the fair value of the derivative is recognised in the Statement of Profit and Loss.

Amounts accumulated in hedging reserve are reclassified to the Statement of Profit and Loss in theperiods when the hedged item affects the Statement of Profit and Loss.

The full fair value of a hedging derivative is classified as a current/ non- current, asset or liabilitybased on the remaining maturity of the hedged item.

When a hedging instrument expires, swapped or unwound, or when a hedge no longermeets thecriteria for hedge accounting, any cumulative gain or loss existing in Statement of Changes in Equityis recognised in the Statement of Profit and Loss.

#### Offsetting financial instruments

Financial assets and liabilities are offset and the net amount reported in the Balance Sheet whenthere is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realize the asset and settle the liability simultaneously.

#### Fair value measurement

The Company classifies the fair value of its financial instruments in the following hierarchy, based on the inputs used in their valuation:

- i) Level 1 The fair value of financial instruments quoted in activemarkets is based on their quoted closing price at the Balance Sheetdate.
- ii) Level 2 The fair value of financial instruments that are not traded inan active market is determined by using valuation techniques using observable market data. Such valuation techniques includediscounted cash flows, standard valuation models based on marketparameters for interest rates, yield curves or foreign exchange rates, dealer quotes for similar instruments and use of comparable arm's length transactions.
- iii) Level 3 The fair value of financial instruments that are measured onthe basis of entity specific valuations using inputs that are not basedon observable market data (unobservable inputs). When the fairvalue of unquoted



instruments cannot be measured with sufficientreliability, the Company carries such instruments at cost lessimpairment, if applicable.

#### (f)Employee Benefits

Salaries and wages paid to employees is recognized as an expense at the undiscounted amounts in the Statement of Profit and Loss of the year in which the related service is rendered.

The Company does not have any policy for deduction of professional Tax, Provident Fund, ESICand/or any other employee benefit plans.

#### (g) Provisions

Provisions are recognized when the Company has a present obligation (legal or constructive) as are sult of a past event, it is probable that an outflow of economic benefits will be required to settlethe obligation, and a reliable estimate can be made of the amount of the obligation.

The amount recognized as a provision is the best estimate of the consideration required to settlethe present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation.

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, the receivable is recognized as an asset, if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

Provisions for onerous contracts are recognized when the expected benefits to be derived by theCompany from a contract are lower than the unavoidable costs of meeting the future obligationsunder the contract. Provisions for onerous contracts are measured at the present value of lower of the expected net cost of fulfilling the contract and the expected cost of terminating the contract.

#### (h) Income Taxes

Income tax comprises current and deferred tax. Income tax expense is recognized in the Statementof Profit and Loss except to the extent it relates to items directly recognized in equity or in othercomprehensive income.

- a) Current income tax Current income tax liability/ (asset) for the current andprior periods are measured at the amount expected to be recovered from orpaid to the taxation authorities based on the taxable income for the year. Thetax rates and tax laws used to compute the current tax amount are those thatare enacted or substantively enacted by the reporting date and applicable forthe year. The Company off sets current tax assets and current tax liabilities, where it has a legally enforceable right to set off therecognized amounts and where it intends either to settle on a net basis or to realize the asset and liability simultaneously.
- b) Deferred tax Deferred income tax is recognized using the Balance Sheetapproach. Deferred income tax assets and liabilities are recognized fordeductible and taxable temporary differences arising between the tax base of assets and liabilities and their carrying amount in financial statements, except then the deferred income tax arises from the initial recognition of goodwillor an asset or liability in a transaction that is not a business combination and affects neither accounting nor taxable profits or loss at the time of the transaction.

Deferred income tax asset is recognized to the extent that it is probable that taxable profit will be against which the deductible temporary differences and the carry forward of unused taxcredits and unused tax losses can be utilized. Deferred income tax liabilities are recognized for alltaxable temporary differences.

The carrying amount of deferred income tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow allor part of the deferred income tax asset to be utilized.



Deferred income tax assets and liabilities are measured at the tax rates that are expected to apply inthe period when the asset is realized or the liability is settled, based on tax rates (and tax laws) thathave been enacted or substantively enacted at the reporting date.

#### (i) Cash flow Statement:

Cash flows are reported using the indirect method, whereby profit for the period is adjusted for theeffects of transactions of anon-cash nature, any deferrals or accruals of past or future operatingcash receipt or payments and item of income or expense associated with investing or financing cashflows. The cash flow from operating, investing and financing activities of the Company aresegregated.

#### (j) Revenue Recognition

The Company derives revenue primarily from production of Advertisement Motion Films. Revenue isrecognized to the extent that it is probable that the economic benefits will flow to the Company, and the revenue can be reliably measured regardless of when the payment is being made. Revenue excludes goods and service tax, sales tax and entertainment tax which are collected by the Companyon behalf of the Government and deposited to the credit of respective Governments.

- (k) Dividend and dividend distribution taxFinal dividends on shares are recorded as a liability on the date of approval by the shareholders and interim dividends are recorded as a liability on the date of declaration by the Company's Board of Directors. The Company declares and pays dividends in Indian rupees and are subject to applicable distribution taxes. The applicable distribution taxes are treated as an appropriation of profits.
- (I) Foreign Currency transactions and translationsTransactions in foreign currency are translated into the respective functional currencies using theexchange rates prevailing at the dates of the respective transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at the exchangerates prevailing at reporting date of monetary assets and liabilities denominated in foreign currencies are recognized in the Statement of Profit and Loss and reported within foreign exchangegains/ (losses).

Non-monetary assets and liabilities denominated in a foreign currency and measured at historicalcost are translated at the exchange rate prevalent at the date of transaction.

Foreign currency gains and losses are reported on a net basis. This includes changes in the fair valueof foreign exchange derivative instruments, which are accounted at fair value through profit or loss.

(m) Finance Income and expenseFinance income consists of interest income on funds invested, dividend income and fair value gainson the FVTPL financial assets. Interest income is recognized as it accrues in the statement of profitand loss, using the effective interest method.

Dividend income is recognized in the statement of profit and loss on the date that the Company's right to receive payment is established.

Finance expenses consist of interest expense on loans and borrowings. Borrowing costs are recognized in the Statement of Profit and Loss using the effective interest method.

#### (n) Earnings per share

Basic earnings per equity share is computed by dividing the net profit attributable to the equityholders of the Company by the weighted average number of equity shares outstanding during theperiod.

Diluted earnings per equity share is computed by dividing the net profit attributable to the equityholders of the Company by the weighted average number of equity shares considered for derivingbasic earnings per equity share and also the weighted average number of equity shares that couldhave been issued upon conversion of all dilutive potential equity shares. The dilutive potential equity shares are adjusted for the proceeds receivable had the equity shares been actually issued atfair value (i.e. the average market value of the outstanding equity shares). Dilutive potential equityshares are deemed converted as at the beginning of the period, unless issued at a later date. Dilutive potential equity shares are determined independently



for each period presented.

#### (o) Contingent Liabilities

Contingent liabilities exist when there is a possible obligation arising from past events, the existenceof which will be confirmed only by the occurrence or non-occurrence of one or more uncertainfuture events not wholly within the control of the Company, or a present obligation that arises frompast events where it is either not probable that an outflow of resources will be required or theamount cannot be reliably estimated. Contingent liabilities are appropriately disclosed unless thepossibility of an outflow of resources embodying economic benefits is remote.

The company has defaulted in timely submission of SEBI statutory statements and has been late infiling statements. The basic fine payable is of Rs. 1,03,32,472 pursuant to SEBI SOP Circularfor the period from March 2014 to March, 2023 as per information given by the management.

The company has not made provision for above referred contingent liabilities in its financial statements. In view of the Management, the company is not liable to pay the penalty and has made representations to the Stock Exchange in this regards.

#### (p) Contingent Assets

A contingent asset is a possible asset that arises from past events and whose existence will beconfirmed only by the occurrence or non-occurrence of one or more uncertain future events notwholly within the control of the entity. The Company does not recognize a contingent asset.

#### (q) Events after the reporting period

Adjusting events are events that provide further evidence of conditions that existed at the end of the reporting period. The financial statements are adjusted for such events before authorisation for such events before authorisation.

Non-adjusting events are events that are indicative of conditions that arose after the end of thereporting period. Non-adjusting events after the reporting date are not accounted, but disclosed.

#### (r) Borrowing Costs

Borrowing costs include interest and amortization of ancillary costs incurred to the extent they are regarded as an adjustment to the interest cost. Costs in connection with the borrowing of funds to the extent not directly related to the acquisition of qualifying assets are charged to the Statement of Profit and Loss over the tenure of the loan. Borrowing costs, allocated to and utilised for qualifying assets, pertaining to the period from commencement of activities relating to construction /development of the qualifying asset up to the date of capitalisation of such asset is added to the cost of the assets. Capitalisation of borrowing costs is suspended and charged to the Statement of Profit and Loss during extended periods when active development activity on the qualifying assets is interrupted.

During the year company has not incurred any borrowing expenses.

#### (s) Rounding of amounts

All amounts disclosed in the financial statements and notes have been rounded off to the nearestrupees as per the requirement of Schedule III, unless otherwise stated.

#### (t) Goods & Service Tax:

GST credit on materials purchased for production / service availed for production/ input service are taken into account at the time of purchase and GST credit on purchase of capitalitems wherever applicable are taken into account as and when the assets are acquired.



The GST credits so taken are utilized for payment of excise duty/GST on sales. The unutilized GSTcredit is carried forward in the books. The GST credits so taken are utilized for payment of tax ongoods sold. The unutilized GST credit, if any, is carried forward in the books.



#### 18. Segment reporting:

The company is engaged in the business of providing Screening and distribution Services. The company is therefore having one business segment, only.

## 19. <u>Details of dues to Micro and Small Enterprises as defined under the Micro, Smalland Medium Enterprises</u> Development Act, 2006.

Total creditors as on 31.03.2023 is Rs. 1,08,64380. Details of classification of creditors into MSMEand non MSME is not available. As per our knowledge there is one creditor as on March 31, 2023 with credit balance of Rs. 1,50,000, which qualifies under dues to Micro and Small Enterprises asdefined under the Micro, Small and Medium Enterprises Development Act,2006. In the absence of additional information, we are not able to comment on the actual outstanding balance as on March31, 2023 payable to Micro and Small Enterprises as defined under the Micro, Small and MediumEnterprises Development Act, 2006.

- 21. On periodical basis and as and when required, the Company reviews the carryingamounts of its assets and found that there is no indication that those assets havesuffered any impairment loss. Hence, no such impairment loss have been provided in the Financial Year 2021-22 (Previous Year Rs. Nil)

#### 22. Financial Instruments and Risk Management

Risk Management FrameworkThe Company's risk management is governed by policies and approved by the board of directors.Company's identifies, evaluates and hedges financial risks in close co- operation with the Company'soperating units. The company has policies for overall risk management, as well as policies coveringspecific areas, such as - exchange risk, interest rate risk, credit risk, use of derivative financialinstruments and non-derivative financial instruments.

The audit committee oversees how management monitors compliance with the company's riskmanagement policies and procedures, and reviews the adequacy of the risk managementframework in relation to the risks faced by the Company. The audit committee is assisted in itsoversight role by internal audit. Internal audit undertakes both regular and ad hoc reviews of riskmanagement controls and procedures, the results of which are reported to the audit committee.

#### a. Credit Risk

Credit risk refers to the risk of default on its obligation by the counterparty resulting in a financialloss. The Company maintains its cash and cash equivalents and bank deposits with banks havinggood reputation, good past track record and high quality credit rating and also reviews their creditworthinesson an on-going basis. The maximum exposure to credit risk at the reporting date isprimarily from trade receivables. Credit risk has always been managed by the company throughcredit approvals, establishing credit limits and continuously monitoring the creditworthiness ofcustomers to which the company grants credit terms in the normal course of business. On account of the adoption of Ind AS 109, the company uses ECL model to assess the impairment loss or gain. The company uses a provision matrix to compute the ECL allowance for trade receivables and unbilled revenues. The provision matrix takes into account available external and internal credit risk factors and the company's experience for customers.

The Company reviews trade receivables on periodic basis and charges to profit and loss accountwhen management feels the amount will not be receivable in future. The Company also calculates the expected credit loss (ECL) for non-collection of receivables.

#### b. Liquid Risk

Liquidity risk is the risk that the Company will encounter difficulty in meeting the obligations associated with its financial liabilities that are settled by delivering cash or another financial asset. The Company's approach to managing liquidity is to ensure, as far as possible, that it will have sufficient liquidity to meet its liabilities when they are due, under both normal and



stressedconditions, without incurring unacceptable losses or risking damage to the Company's reputation. Management regularly monitors the position of cash and cash equivalents vis-à- vis projections. Assessment of maturity profiles of financial assets and liabilities including debt financing plans and maintenance of balance sheet liquidity ratiosare considered while reviewing the liquidity position.

#### **Exposure to Liquid Risk:**

The following are the remaining contractual maturities of financial liabilities at the reporting date. The amounts are gross and undiscounted, and include estimated interest payments and exclude the impact of netting agreements.

#### c. Market Risk

Market risk is the risk that the fair value or future cash flow of a financial instrument will fluctuatebecause of changes in market factors. Market risk comprises two types of risks:

#### a) Currency Risk

The functional currency of the Company is Indian Rupee. The Company is exposed to currency riskon account of receivables in foreign currency. Company is exposed to currency risk on account of receivables in foreign currency. The company does not have any unhedged foreign currency exposure as on 31/03/2023.

#### b) Price Risk

As of 31st March 2023, the company has nil exposure on security price risks.

#### d. Fair value measurement

Fair value is the price that would be received to sell an asset or paid to transfer a liability in anorderly transaction between market participants at the measurement date under current marketconditions.

The Company categorizes assets and liabilities measured at fair value into one of three levelsdepending on the ability to observe inputs employed in their measurement which are described asfollows:

- (a) Level 1 inputs are quoted prices (unadjusted) in active markets for identicalassets or liabilities.
- (b) Level 2 inputs are inputs that are observable, either directly or indirectly, otherthan quoted prices included within level 1 for the asset or liability.
- (c) Level 3 inputs are unobservable inputs for the asset or liability reflecting significant modifications to observable related market data or Company's assumptions about pricing by market participants.

The carrying amount of cash and cash equivalents, trade receivables, trade payablesconsidered tobe the same as their values due to their short term nature.

#### **Report on the Financial Statements**

We have audited the accompanying consolidated financial statements of M/s. VISION CINEMAS LIMITED ("the Company"), which comprise the Consolidated Balance Sheet as at 31st March, 2023, the Consolidated Statement of Profit and Loss, the Consolidated Cash Flow Statement, and a Summary of the significant accounting policies and other explanatory information for the year then ended.

## Responsibilities of Management and Those charged with Governance for the ConsolidatedFinancial Statements

#### **Emphasis of Matter**

- The balances reported as Trade Payable are subject to confirmation of balances from the Vendors.
- Of Rs.977.96 lakhs of aggregate Trade Receivable as on 31<sup>st</sup> March, 2023, Rs. 938.03 Lakhs receivable from M/s. SI Media LLP, which accumulated during earlier periods. However, the net receivable from SI Media has reduced from Rs. 953.04 Lakhs on 31.03.2022 to Rs. 938.03 Lakhs as on 31<sup>st</sup> March, 2023. Also, the management is confident of its recoverability and we find the explanation provided by the management on the same appropriate.

Auditor's opinion is not modified in respect of the matter emphasized.

#### Report On Other Legal and Regulatory Requirements

  - (j) we have sought and obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of our audit.

  - (l) The ConsolidatedBalance sheet, the Consolidated statement of Profit and Loss, the ConsolidatedCash Flow statement and the Consolidated Statement of Changes in Equity dealt with by this Report are in agreement with those books of accounts.
  - (m)ln our opinion, the financial statements does not comply with the Ind AS specified under section 133 of the Act, read with Rule 7 of the Companies (Accounts) Rules, 2014.



- (n) on the basis of the written representations received from the Directors as on 31st March, 2023 taken on record by the Board of Directors none of the directors is disqualified as on 31st March, 2023 from being appointed as a director in terms of Section 164 (2) of the Act.
- (o) With respect to the adequacy of the internal financial controls over financial reporting and the operating effectiveness of such controls, refer to our separate report in "Annexure A" which is based on the auditor's reports of the Company and its subsidiary company incorporated in India. Our report expresses an unmodified opinion on the adequacy and operating effectiveness of the internal financial controls over financial reporting of those companies.
- (p) With respect to the other matters to be included in the Auditor's Report in accordance with the requirements of section 197(16) of the Act, as amended, we report that no remuneration was paid to any of the Directors during the year.
- (q) With respect to the other matters to be included in the Auditors' Report in accordance with Rule 11 of the Companies (Audit and Auditors) Rules, 2014, in our opinion and to the best of our information and according to the explanations given to us:
  - viii. The ParentCompany has below pending litigations which may have impact on its standalone financial statements:
    - A matter has been filed by SEBI against promoters of the company for preferential allotment of shares in their name. The Hon. Mumbai High Court has passed a Stay order favouring the promoters against SEBI regarding this matter.
    - Penalties imposed by the Bombay Stock Exchange on the Parent Company on various grounds. The Parent Company has made a representation contesting the grounds for imposition of these penalties and the relevant documentation/ supporting are presented and are under consideration of the Stock Exchange for waiver of the same.
  - ix. The Group does not have any long-term contracts including derivative contracts for which there are any foreseeable losses.
  - x. There were no amounts which are required to be transferred to Investor Education and Protection Fund by the Company and its Subsidiary.

company shall, whether, directly or indirectly, lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the Funding Party ("Ultimate Beneficiaries") or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries; and

- xiii. Based on audit procedures which we considered reasonable and appropriate in the circumstances, nothing has come to our notice that has caused us to believe that the representations under sub-clause (v) and (vi) contain any material mis-statement.
- xiv. The company has not declared or paid any dividend during the year in contravention of the provisions of section 123 of the Companies Act, 2013.
- 4. With respect to the matters specified in paragraphs 3(xxi) and 4 of the Companies (Auditor's Report) Order, 2020 (the "Order"/ "CARO") issued by the Central Government interms of Section 143(11) of the Act, to be included in the Auditor's report, according to the information and explanations given to us, and based on the CARO reports issued by us for the Company and its subsidiaries included in the consolidated financial statements of the Company, to which reporting under CARO is applicable, we report that there are no qualifications or adverse remarks in these CARO reports.

# **Notes forming part of Consolidated Financial Statements**

# 1. CORPORATE INFORMATION

The Consolidated financial statements of Vision Cinemas Limited is made up of the Vision Cinemas Limited together with its subsidiaries Pyramid Entertainment India Pvt Ltd. (collectively referred to as the "Group").

The Company Is engaged in the business of movie exhibition. The company earns revenue from screening income and distribution income.

The Vision Cinemas Limited is a public limited company incorporated in India and the Company has its primary listing on Bombay Stock Exchange.

The principal accounting policies applied in the preparation of the consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

### 2. SIGNIFICANT ACCOUNTING POLICIES

BASIS OF PREPARATION & PRESENTATION OF FINANCIAL STATEMENTS

### (a) Statement of Compliance

These consolidated financial statements have not been prepared in accordance with the Indian Accounting Standards (referred to as "Ind AS") as prescribed under section 133 of the Companies Act, 2013 read with Companies (Indian Accounting Standards) Rules as amended from time to time.

### (b) Basis of measurement

The consolidated financial statements have been prepared on a historical cost convention and on an accrual basis, except for certain financial instruments which are measured at fair value at end of the each reporting period, as explained in the accounting policies below.

# (c) Use of judgement, estimates and assumptions

The preparation of the financial statements requires the management to make judgements, estimates and assumptions considered in the reported amounts of assets and liabilities and disclosure relating to contingent liabilities as at the date of consolidated financial statement and the reported amounts of income and expenditure during the reported year. Estimates and underlying assumptions are reviewed on a periodic basis. Revisions to accounting estimates are recognized in the period in which the estimates are revised and in any future periods affected.

In particular, information about significant areas of estimation, uncertainty and critical judgments in applying accounting policies that have the most significant effect on the amounts recognized in the consolidated financial statements is included in the following notes:

# i) Income taxes

The Group's major tax jurisdictions is India. Significant judgments are involved in determining the provision for income taxes, including amount expected to be paid/recovered for uncertain tax positions. In assessing the realizability of deferred income tax assets, management considers whether some portion or all of the deferred income tax assets will not be realized. The realization of deferred income tax assets is dependent upon the generation of future taxable income during the periods in which the temporary differences become deductible. Management considers the

scheduled reversals of deferred income tax liabilities, projected future taxable income and tax planning strategies in making this assessment. Based on the level of historical taxable income and projections for future taxable income over the periods in which the deferred income tax assets are deductible, management believes that the company will realize the benefits of those deductible differences. The amount of the deferred income tax assets considered realizable, however, could be reduced in the near term if estimates of future taxable income during the carry forward period are reduced.

# ii) Impairment testing

Investments in goodwill and intangible assets are tested for impairment annually and when events occur or changes in



circumstances indicate that the recoverable amount of the asset or cash generating units to which these pertain is less than its carrying value. The recoverable amount of cash generating units is higher of value-in-use and fair value less cost to dispose. The calculation of value in use of a cash generating unit involves use of significant estimates and assumptions which includes turnover and earnings multiples, growth rates and net margins used to calculate projected future cash flows, risk-adjusted discount rate, future economic and market conditions.

#### iii) Depreciation and amortisation

Depreciation and amortisation is based on management estimates of the future useful lives of certain class of property, plant and equipment and intangible assets. Estimates may change due to technological developments, competition, changes in market conditions and other factors and may result in changes in the estimated useful life and in the depreciation and amortisation charges.

#### iv) Other estimates

The preparation of Consolidated financial statements involves estimates and assumptions that affect the reported amount of assets, liabilities, disclosure of contingent liabilities at the date of consolidated financial statements and the reported amount of revenues and expenses for the reporting period. Specifically, the Company estimates the probability of collection of accounts receivable by analyzing historical payment patterns, customer concentrations, customer credit worthiness and current economic trends. If the financial condition of a customer deteriorates, additional allowances may be required.

The stock compensation expense is determined based on the Company's estimate of equity instruments that will eventually vest

Fair valuation of derivative hedging instruments designated as cash flow hedges involves significant estimates relating to the occurrence of forecast transaction.

# **Principles of Consolidation and equity accounting**

### Subsidiary companies

Subsidiary companies are all entities over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the relevant activities of the entity. Subsidiary companies are fully consolidated from the date on which control is obtained by the Group. They are deconsolidated from the date that control ceases.

The acquisition method of accounting is used to account for business combinations by the Group.

The Group combines the Consolidated Financial Statements of the parent and itssubsidiary companies line by line adding together like items of assets, liabilities, equity, income and expenses. Intercompany transactions, balances and unrealised gains on transactions between Group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. Accounting Policies of subsidiary companies have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests in the results and equity of subsidiary companies are shown separately in the Consolidated Statement of Profit and Loss, ConsolidatedStatement of changes in equity and Consolidated Balance Sheet respectively.



### Equity Method

Under the equity method of accounting, the investments are initially recognisedat cost and adjusted thereafter to recognise share of the Group in postacquisition profit and loss of the investee in profit and loss, and share of the Group in Other Comprehensive Income of the investee in OtherComprehensiveIncome. Dividends received or receivable from subsidiary Company are recognised as a reduction in the carrying amount of the investment.

When the Group's share of losses in an equity-accounted investment equals or exceeds its interest in the entity, including any other unsecured long-termreceivables, the Group does not recognise further losses, unless it has incurredobligations or made payments on behalf of the other entity.

Unrealised gains on transactions between the Group and its subsidiaryCompany are eliminated to the extent of the Group interest in these entities.

Unrealised losses are also eliminated unless the transaction provides evidenceof an impairment of the asset transferred. Accounting Policies of equityaccounted investees have been changed where necessary to ensureconsistency with the policies adopted by the Group. The carrying amount of

equity accounted investments are tested for impairment in accordance with thepolicy described in(ix) below.

# Change in ownership interest

The Group treats transactions with non-controlling interests that do not result in a loss of control as transactions with equity owners of the Group. A change inownership interest results in anadjustment between the carrying amounts of the controlling and non-controlling interests to reflect their relative interest in the subsidiary companies. Any difference between the amount of the adjustment to non-controlling interests and any consideration paid or received is recognised within equity.

When the Group ceases to consolidate or equity account for an investment because of a loss of control, joint control or significant influence, any retained interest in the entity is remeasured to its fair value with the change in carrying amount recognised in the Consolidated Statement of Profit and Loss. This fairvalue becomes the initial carrying amount for the purpose of subsequent accounting for the retained interest as an associate, joint venture or financial asset. In addition, any amount previously recognised in Other Comprehensive Income in respect of that entity are accounted for as if the Group had directly disposed of the related assets or liabilities. This may mean that amounts

previously recognised in Other Comprehensive Income are reclassified to the Consolidated Statement of Profit and Loss.

If the ownership interest in a joint venture Company or an associate is reduced but joint control or significant influence is retained, only a proportionate shareof the amounts previously recognised in Other Comprehensive Income are reclassified to the Consolidated Statement of Profit and Loss where appropriate.

### **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### (a) Functional and presentation currency

Items included in the Consolidated financial statements of the Company are measuredusing the currency of the primary economic environment in which the Companyoperates (i.e. the "functional currency"). The financial statements are presented inIndian Rupee, the national currency of India, which is the functional currency of theCompany. The functional currency of its subsidiary is also Indian Rupee.

# (b) Property, plant and equipment

Property, plant and equipment are measured at historical cost or its deemed cost lessaccumulated depreciation and impairment losses, if any. Historical Cost includes expenditures directly attributable to the acquisition of the asset.

When parts of an item of property, plant and equipment have different useful lives, they are accounted for as separate items (major components) of property, plant and equipment. Subsequent expenditure relating to property, plant and equipment iscapitalized only when it is probable that future economic benefits associated withthese will flow to the Company and the cost of the item can be measured reliably. Repairs and maintenance costs are recognized in the statement of profit and



losswhen incurred.

An item of property, plant and equipment is derecognized upon disposal or when nofuture economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognized in the Statement of Profit and Loss.

# (c) Depreciation/ Amortisation

Depreciable amount for assets is the cost of asset less its estimated residual value.

Depreciation has been provided on all assets on the straightline method, as per theuseful life prescribed in Schedule II of the Companies Act, 2013.

The residual values, useful lives and methods of depreciation of property, plant and equipment are reviewed at each financial year end and adjusted prospectively, ifappropriate. The Company assesses at each Balance Sheet date whether there isobjective evidence that a asset or a group of assets is impaired. An asset's carryingamount is written down immediately to its recoverable amount if the asset's carryingamount is greater than its estimated recoverable amount.

All the assets of Parent Company except building are at residual value as on 1st April,2021 and hence depreciation is provided only on building value amount. Depreciation on all the assets of subsidiary company are provided according to the applicable rates.

The residual values are not more than 5% of the original cost of assets.



# (d) Leases

From April 1, 2019, Ind AS 116 'Leases' is applicable to all the listed companies. Ind AS116 has certain exemptions from the application of Ind AS – 116:

As per explanation and books of accounts provided to us, there are no lease payments done by the company and as per the explanation provided to us, no lease agreements are entered into by the company.

### (e) Financial Instruments

All financial instruments are recognised initially at fair value. Transaction costs that are attributable to the acquisition of the financial asset (other than financial assets recorded at fair value through profit or loss) are included in the fair value of the financial assets. Purchase or sale of financial assets that require delivery of assets within a time frame established by regulation or convention in themarket place (regular way trade) are recognised on trade date. While, loans and borrowings and

payables are recognised net of directly attributable transaction costs.

For the purpose of subsequent measurement, financial instruments of the Group areclassified in the following categories: non-derivative financial assets comprisingamortised cost, debt instruments at fair value through other comprehensive income(FVTOCI), equity instruments at FVTOCI or fair value through profit and loss account(FVTPL), non derivative financial liabilities at amortised cost or FVTPL and derivative financial instruments (under the category of financial assets or financial liabilities) at

FVTPL.

The classification of financial instruments depends on the objective of the businessmodel for which it is held. Management determines the classification of its financialinstruments at initial recognition.

### Non-derivative financial assets

Financial assets at amortised cost

A financial asset shall be measured at amortised cost if both of the following conditions are met:

- (a) the financial asset is held within a business model whose objective is to holdfinancial assets in order to collect contractual cash flows; and
- (b) the contractual terms of the financial asset give rise on specified dates tocash flows that are solely payments of principal and interest (SPPI) on the principal amount outstanding.

They are presented as current assets, except for those maturing later than 12months after the reporting date which are presented as non-current assets. Financial assets are measured initially at fair value plus transaction costs and subsequently carried at amortized cost using the effective interest rate method, less any impairment loss.

Financial assets at amortised cost are represented by trade receivables, securitydeposits, cash and cash equivalents, employee and other advances and eligible current and non-current assets.

Cash and cash equivalents comprise cash on hand and in banks and demanddeposits with banks which can be withdrawn at any time without prior notice orpenalty on the principal.

For the purposes of the cash flow statement, cash and cash equivalents includecash on hand, in banks and demand deposits with banks, net of outstanding bankoverdrafts that are repayable on demand, book overdraft and are considered partof the Company's cash management system.



# ii. Financial Assets at Fair Value through Other Comprehensive Income(FVTOCI)

For assets, if it is held within a business model whose objective is achieved byboth collecting contractual cash flows and selling financial assets and where the company has exercised the option to classify the equity investment as at FVTOCI, all fair value changes on the investment are recognised in OCI. The accumulatedgains or losses on such investments are not recycled to the Statement of Profit and Loss even on sale of such investment.

# iii. Financial assets at Fair Value through Profit and loss (FVTPL)

Financial assets which is not classified in any of the above category is measured at FVTPL. These include surplus funds invested in mutual funds etc.

Financial assets included within the FVTPL category are measured at fair values with all changes recorded in the statement of profit and loss.

#### Non-derivative financial liabilities

#### Financial liabilities at amortised cost

Financial liabilities at amortised cost represented by borrowings, trade and otherpayables are initially recognized at fair value, and subsequently carried atamortized cost using the effective interest rate method. For trade and otherpayable maturing within one year from the Balance Sheet date, the carryingvalue approximates fair value due to short maturity.

# Financial liabilities at Fair Value through Profit and loss (FVTPL)

Financial liabilities at FVTPL represented by contingent consideration are measured at fair value with all changes recognized in the statement of profit and loss.

# Derivative financial instruments and hedging activities

A derivative is a financial instrument which changes value in response to changesin an underlying asset and is settled at a future date. Derivatives are initially recognised at fair value on the date a derivative contract is entered into and are subsequently re-measured at their fair value. The method of recognizing the resulting gain or loss depends on whether the derivative is designated as ahedging instrument, and if so, the nature of the item being hedged.

The Group enters into derivative contracts to hedge the risks asserted withcurrency fluctuations relating to firm commitments and highly probable transactions. The Company does not use derivative instruments for speculative purposes.

The Group documents, at the inception of the transaction, the relationshipbetween hedging instruments and hedged items, as well as its risk managementobjectives and strategy for undertaking various hedging transactions. The Groupalso documents its assessment, both at hedge inception and on an on-goingbasis, of whether the derivatives that are used in hedging transactions are effective in offsetting changes in cash flows of hedged items.

The effective portion of changes in the fair value of derivatives that are designated and qualify as cash flow hedges is recognised in OtherComprehensive Income. The ineffective portion of changes in the fair value of the derivative is recognised in the Consolidated Statement of Profit and Loss.

Amounts accumulated in hedging reserve are reclassified to the ConsolidatedStatement of Profit and Loss in the periods when the hedged item affects theConsolidated Statement of Profit and Loss.

The full fair value of a hedging derivative is classified as a current/ non- current, asset or liability based on the remaining maturity of the hedged item.

When a hedging instrument expires, swapped or unwound, or when a hedge nolonger meets the criteria for hedge



accounting, any cumulative gain or lossexisting in Consolidated Statement of Changes in Equity is recognised in the Consolidated Statement of Profit and Loss.

# Offsetting financial instruments

Financial assets and liabilities are offset and the net amount reported in the Consolidated Balance Sheet when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realize the asset and settle the liability simultaneously.

#### Fair value measurement

The Group classifies the fair value of its financial instruments in the following hierarchy, based on the inputs used in their valuation:

- i) Level 1 The fair value of financial instruments quoted in active marketsis based on their quoted closing price at the Balance Sheet date.
- ii) Level 2 The fair value of financial instruments that are not traded in anactive market isdetermined by using valuation techniques using observable market data. Such valuation techniques include discountedcash flows, standard valuation models based on market parameters forinterest rates, yield curves or foreign exchange rates, dealer quotes forsimilar instruments and use of comparable arm's length transactions.
- iii) Level 3 The fair value of financial instruments that are measured on thebasis of entity specific valuations using inputs that are not based onobservable market data (unobservable inputs). When the fair value ofunquoted instruments cannot be measured with sufficient reliability, the Company carries such instruments at cost less impairment, if applicable.

# (f) Employee Benefits

Salaries and wages paid to employees is recognized as an expense at the undiscountedamounts in the Statement of Profit and Loss of the year in which the related service isrendered.

The Company does not have any policy for deduction of professional Tax, ProvidentFund, ESIC and/or any other employee benefit plans.

#### (g) Provisions

Provisions are recognized when the Group has a present obligation (legal orconstructive) as a result of a past event, it is probable that an outflow of economicbenefits will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation. The amount recognized as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation.

When some or all of the economic benefits required to settle a provision are expected be recovered from a third party, the receivable is recognized as an asset, if it isvirtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

Provisions for onerous contracts are recognized when the expected benefits to be erived by the Group from a contract are lower than the unavoidable costs of meetingthe future obligations under the contract. Provisions for onerous contracts are measured at the present value of lower of the expected net cost of fulfilling the contract and the expected cost of terminating the contract.

#### (h) Income Taxes

Income tax comprises current and deferred tax. Income tax expense is recognized in the Consolidated Statement of Profit and Loss except to the extent it relates to itemsdirectly recognized in equity or in other comprehensive income.



- a) Current income tax Current income tax liability/ (asset) for the current andprior periods are measured at the amount expected to be recovered from or paidto the taxation authorities based on the taxable income for the year. The tax ratesand tax laws used to compute the current tax amount are those that are enactedor substantively enacted by the reporting date and applicable for the year. TheGroup off sets current tax assets and current tax liabilities, where it has a legallyenforceable right to set off the recognized amounts and where it intends either tosettle on a net basis or to realize the asset and liability simultaneously.
- b) **Deferred tax** Deferred income tax is recognized using the Balance Sheetapproach. Deferred income tax assets and liabilities are recognized for deductibleand taxable temporary differences arising between the tax base of assets andliabilities and their carrying amount in financial statements, except when the deferred income tax arises from the initial recognition of goodwill or an asset orliability in a transaction that is not a businesscombination and affects neither accounting nor taxable profits or loss at the timeof the transaction.

Deferred income tax asset is recognized to the extent that it is probable thataxable profit will be available against which the deductible temporary differencesand the carry forward of unused tax credits and unused tax losses can be utilized. Deferred income tax liabilities are recognized for all taxable temporary differences.

The carrying amount of deferred income tax assets is reviewed at each reportingdate andreduced to the extent that it is no longer probable that sufficient taxableprofit will be available to allow all or part of the deferred income tax asset to beutilized.

Deferred income tax assets and liabilities are measured at the tax rates that are expected to apply in the period when the asset is realized or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted at the reporting date.

### (i) Cash flow Statement:

Cash flows are reported using the indirect method, whereby profit for the period isadjusted for the effects of transactions of a non-cash nature, any deferrals or accrualsof past or future operating cash receipt or payments and item of income or expenseassociated with investing or financing cash-flows. The cash flow from operating, investing and financing activities of the Group are segregated.



# (j) Revenue Recognition

The Group derives revenue primarily from screening and distribution income. Revenueis recognized to the extent that it is probable that the economic benefits will flow to the Group, and the revenue can be reliably measured regardless of when the paymentis being made. Revenue excludes goodsand service tax, sales tax and entertainmenttax which are collected by the Group on behalf of the Government and deposited to thecredit of respective Governments.

# (k) Dividend and dividend distribution tax

Final dividends on shares are recorded as a liability on the date of approval by theshareholders and interim dividends are recorded as a liability on the date ofdeclaration by the Company's Board of Directors. The Company declares and paysdividends in Indian rupees and are subject to applicable distribution taxes. The applicable distribution taxes are treated as an appropriation of profits.

# (I) Foreign Currency transactions and translations

Transactions in foreign currency are translated into the respective functional currenciesusing the exchange rates prevailing at the dates of the respective transactions.

Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at the exchange rates prevailing at reporting date of monetary assets and liabilities denominated in foreign currencies are recognized in the consolidated Statement of Profit and Loss and reported within foreign exchange gains/(losses).

Non-monetary assets and liabilities denominated in a foreign currency and measured athistorical cost are translated at the exchange rate prevalent at the date of transaction.

Foreign currency gains and losses are reported on a net basis. This includes changes in the fair value of foreign exchange derivative instruments, which are accounted at fairvalue through profit or loss.

# (m) Finance Income and expense

Finance income consists of interest income on funds invested, dividend income and fairvalue gains on the FVTPL financial assets. Interest income is recognized as it accrues inthe statement of profit and loss, using the effective interest method.

Dividend income is recognized in the Consolidated statement of profit and loss on thedate that the Group's right to receive payment is established.

Finance expenses consist of interest expense on loans and borrowings. Borrowing costsare recognized in the Consolidated Statement of Profit and Loss using the effective interest method.

#### (n) Earnings per share

Basic earnings per equity share is computed by dividing the net profit attributable to theequityholders of the Company by the weighted average number of equity sharesoutstanding during the period.

Diluted earnings per equity share is computed by dividing the net profit attributable to the equity holders of the Company by the weighted average number of equity sharesconsidered for deriving basic earnings per equity share and also the weighted averagenumber of equity shares that could have been issued upon conversion of all dilutivepotential equity shares. The dilutivepotential equity shares are adjusted for the proceeds receivable had the equity sharesbeen actually issued at fair value (i.e. the average market value of the outstanding equity shares). Dilutive potential equity shares are deemed converted as at the beginning of the period, unless issued at a later date. Dilutive potential equity shares are determined independently for each period presented.

# (o) Contingent Liabilities

Contingent liabilities exist when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or nonoccurrence of one or more uncertain future events not wholly within the control of the Group, or apresent obligation that arises from pastevents where it is either not probable that anoutflow of resources will be required or the amount cannot be reliably estimated. Contingent liabilities are appropriately disclosed unless the possibility



of an outflow ofresources embodying economic benefits is remote.

The group has defaulted in timely submission of SEBI statutory statements and hasbeen late in filing statements. The basic fine payable is of Rs. 1,03,32,472 pursuant to SEBI SOP Circular for the period from March – 2014 to March-2021. The group has notmade provision for above referred contingent liabilities in its financial statements.

# (p) Contingent Assets

A contingent asset is a possible asset that arises from past events and whose existencewill be confirmed only by the occurrence or non-occurrence of one or more uncertainfuture events not wholly within the control of the entity. The Group does not recognize contingent asset.

# (g) Events after the reporting period

Adjusting events are events that provide further evidence of conditions that existed at the end of the reporting period. The financial statements are adjusted for such eventsbefore authorisation for issue.

Non-adjusting events are events that are indicative of conditions that arose after theend of the reporting period. Non-adjusting events after the reporting date are notaccounted, but disclosed.

### (r) Borrowing Costs

Borrowing costs include interest and amortization of ancillary costs incurred to theextent they are regarded as an adjustment to the interest cost. Costs in connection withthe borrowing of funds to the extent not directly related to theacquisition of qualifying assets are charged to the Statement of Profit and Loss over thetenure of the loan. Borrowing costs, allocated to and utilised for qualifying assets, pertaining to the period from commencement of activities relating to construction /development of the qualifying asset up to the date of capitalisation of such asset isadded to the cost of the assets. Capitalisation of borrowing costs is suspended andcharged to the Statement of Profit and Loss during extended periods when activedevelopment activity on the qualifying assets is interrupted. During the year company has not incurred any borrowing expenses.

#### (s) Rounding of amounts

All amounts disclosed in the financial statements and notes have been rounded off to the nearest rupees as per the requirement of Schedule III, unless otherwise stated.

# (t) Goods & Service Tax:

GST credit on materials purchased for production / service availed for production/ input service are taken into account at the time of purchase and GST credit onpurchase of capital items wherever applicable are taken into account as and when theassets are acquired.

The GST credits so taken are utilized for payment of excise duty/GST on sales. Theunutilized GST credit is carried forward in the books. The GST credits so taken areutilized for payment of tax on goods sold. The unutilized GST credit, if any, is carriedforward in the books.

The company is engaged in the business of providing Screening and distribution Services. The company is therefore having one business segment, only.

# Risk Management Framework

The Company's risk management is governed by policies and approved by the board of directors. Company's identifies, evaluates and hedges financial risks in close co- operation with the Company's operating units. The company has policies for overall risk management, as well aspolicies covering specific areas, such as foreign exchange risk, interest rate risk, credit risk, use ofderivative financial instruments and non-derivative financial instruments.

The audit committee oversees how management monitors compliance with the company's riskmanagement policies and procedures, and reviews the adequacy of the risk managementframework in relation to the risks faced by the Company. The audit committee is assisted in itsoversight role by internal audit. Internal audit undertakes both regular and ad hoc reviews of riskmanagement controls and procedures, the results of which are reported to the audit committee.

#### a. Credit Risk

Credit risk refers to the risk of default on its obligation by the counterparty resulting in afinancial loss. The Company maintains its cash and cash equivalents and bank deposits with banks having good reputation, good past track record and high quality credit ratingand also reviews their credit-worthiness on an on-going basis. The maximum exposure tocredit risk at the reporting date is primarily from trade receivables. Credit risk hasalways been managed by the company through credit approvals, establishing credit limits and continuously monitoring the creditworthiness of customers to which the company grants credit terms in the normal course of business. On account of the adoption of Ind AS 109, the company uses ECL model to assess the impairment loss orgain. The company uses a provision matrix to compute the ECL allowance for tradereceivables and unbilled revenues. The provision matrix takes into account available external and internal credit risk factors and the company's experience for customers.

The Company reviews trade receivables on periodic basis and charges to profit andloss account when management feels the amount will not be receivable in future. The Company also calculates the expected credit loss (ECL) for non-collection of receivables.

### b. Liquid Risk

Liquidity risk is the risk that the Company will encounter difficulty in meeting theobligations associated with its financial liabilities that are settled by delivering cash oranother financial asset. The Company's approach to managing liquidity is to ensure, asfar as possible, that it will have sufficient liquidity to meet its liabilities when they aredue, under both normal and stressed conditions, without incurring unacceptable lossesor risking damage to the Company's reputation. Management regularly monitors the position of cash and cash equivalents vis-à- visprojections. Assessment of maturity profiles of financial assets and liabilities includingdebt financing plans and maintenance of balance sheet liquidity ratios are considered while



reviewing the liquidity position.

### Exposure to Liquid Risk:

The following are the remaining contractual maturities of financial liabilities at thereporting date. The amounts are gross and undiscounted, and include estimated interest payments and exclude the impact of netting agreements.

### c. Market Risk

Market risk is the risk that the fair value or future cash flow of a financialinstrument will fluctuate because of changes in market factors. Market riskcomprises two types of risks:

# a) Currency Risk

The functional currency of the Company is Indian Rupee. The Company isexposed to currency risk on account of receivables in foreign currency.

#### b) Price Risk

As of 31st March 2023, the company has nil exposure on security price risks.

#### d. Fair value measurement

The Company categorizes assets and liabilities measured at fair value into one of threelevels depending on the ability to observe inputs employed in their measurement whichare described as follows:

- (a) Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets orliabilities.
- (b) Level 2 inputs are inputs that are observable, either directly or indirectly, other thanquoted prices included within level 1 for the asset or liability.
- (c) Level 3 inputs are unobservable inputs for the asset or liability reflecting significant modifications to observable related market data or Company's assumptions about pricing by market participants

The carrying amount of cash and cash equivalents, trade receivables, trade payables considered to bethe same as their values due to their short-term nature.
